



## Guidelines for Ordering Bluetongue Vaccine

- Vaccine for use in Wales must be ordered separately from that which will be used in England.
- Until further notice, orders for Bluetongue Vaccine will only be processed if they are received on the enclosed fax back order form.
- No telephone or electronic orders will be processed.
- Bluetongue Vaccine will only be supplied to those veterinary practices vaccinating animals within the DEFRA defined Protection Zone.
- All orders must be signed by a veterinary surgeon. Orders received without a veterinary surgeon signature will not be processed.
- W&J Dunlop Ltd will accept advance vaccine orders for animals currently outside the Protection Zone, but which may become included at a later date. Vaccine will only be supplied to animals within the Protection Zone at the time of ordering.
- Infected Premise (IP) orders should be listed as a single line on the order form quoting the IP reference number.
- Other orders need to be summarised by county.
- Faxed orders will be logged chronologically. If there is a shortage in the supply of the vaccine from the manufacturer orders will be fulfilled on a first come first serve basis. Practices are therefore urged to organise their requirements as soon as possible to avoid potential disappointment.

2. DEFRA have the right to inspect wholesaler sales data and significant penalties are in place for those shown to be ignoring guidelines or stock piling vaccine.
3. Bluetongue vaccine cannot be returned to the wholesaler for credit under any circumstances
4. Orders to cover cattle vaccinations should include both doses.
5. Vaccine orders require full cold chain down to the individual farm
